This agreement made and entered into this 13 day of April 2024, by and between:

And

HARMONY-NORTH HARMONY HISTORICAL SOCIETY 1943 Open Meadows Road Ashville, New York, hereinafter referred to as "ORGANIZATION."

WITNESSETH:

WHEREAS, TOWN is a municipal corporation existing under and by virtue of the State of New York; and

WHEREAS, ORGANIZATION is a not-for-profit organization providing services to both its members and the general public; and

WHEREAS, TOWN and ORGANIZATION desire to enter into a contract wherein; and WHEREBY ORGANIZATION will provide services to TOWN and its residents; NOW, THEREFORE, it is hereby agreed by and between TOWN and ORGANIZATION as follows:

- 3. ORGANIZATION shall provide office space and file storage for the managing and retention of historical records as the TOWN may from time to time provide to the ORGANIZATION.
- 4. TOWN shall assist with improvement and maintenance of the ORGANIZATION's parking lot from time to time as required.
- 5. ORGANIZATION agrees to hold TOWN harmless as a consequence of any action for damages which may be brought against TOWN by reason of ORGANIZATION providing such services to TOWN.
- 6. This agreement is authorized by the following statute or statutes: General Municipal Law and Town Law.

WHEREAS, Chautauqua Lake is an invaluable asset to Chautauqua County and the municipalities that border it including the Town of North Harmony ("Town"), but has been designated as an impaired water body and its health and usability are threatened; and

WHEREAS, Town and the Chautauqua Lake and Watershed Management Alliance ("Alliance") are partnering to complete an engineering design report for a problematic section of Ball Creek that will guide future restoration efforts; and

WHEREAS, Town was awarded a Round 3 Nonpoint Source Planning Grant ("NPG") Number T01464GG, from the New York State ("NYS") Department of Environmental Conservation ("DEC") for the Town of North Harmony Ball Creek Stabilization Engineering Study Phase 1 ("Project"), and

WHEREAS, Town is committed to retain the professional services of a licensed professional engineer to provide the services described in the Town's solicitation documents for the Project; and

WHEREAS, Town issued a Request for Quotes ("RFQ") for Engineering Services dated March 6, 2024, and has identified an engineer best-suited to perform these professional services based on the specifics of the Project and in accordance with the Town's Procurement Policy; and

WHEREAS, the engineer is able and willing to perform the professional services for the Project; therefore be it

**RESOLVED,** that the Town Board of the Town of North Harmony awards the engineering contract for the Town of North Harmony Ball Creek Stabilization Study Phase 1 to JM Davidson Engineering D.P.C. for an amount not to exceed \$30,150.00; and that the Town Supervisor is authorized to execute a contract with JM Davidson Engineering D.P.C. and act in all matters related to the contract.
